Bat World Sanctuary is dedicated to the care, rehabilitation and release of injured bats as well as a sanctuary for non-releasable bats. This year 954 bats were rescued while another 764 were released.

We also built the Bat Castle, a wild bat sanctuary capable of providing habitat for over 100,000 wild bats. Also in 2012 Bat World Sanctuary became accredited with the American Sanctuary Association, was verified with the Global Federation of Animal Sanctuaries, received a "Top Rated" award from Great Non-Profits, and won one of the largest defamation lawsuits in the country against a cyber-stalker.

Bat World Sanctuary engages in raising the awareness of the public through speaking engagements, publications and promotional items showing bats in a positive context, and online communication about bats through our website and facebook page. This year, we partnered with Animal control and Texas Department of State Health Services to provide continuing education on safe handling of bats for Animal Control officers throughout the state. We published three new bat books: The Essential Bat Book, Baby See-Through, and Lil Drac's Big Story. We reached over a million people through educational events and online videos and posts.
