Bat World Sanctuary is dedicated to the care, rehabilitation and release of injured bats as well as a sanctuary for non-releasable bats. This year 627 bats were rescued, and 613 of these were released back into the wild. We completed construction of a 7,200 sq ft new facility designed specifically to rescue bats in need. As the only accredited sanctuary for bats in the world, we continue to collaborate with US Fish and Wildlife Department on efforts to control White Nose Syndrome. We developed continuing education programs for Animal Services officers, structural pest control operators and the USDA. Our activism included stopping a fatal research project that captured pregnant big brown bats from the wild to do See Form 990, Page 2, Part III, Line 4a (continued)

Bat World Sanctuary engages in raising the awareness of the public through speaking engagements, publications and promotional items showing bats in a positive context, and online communication about bats through our website and social media pages. This year we reached over 2 million people online with information about bats. We presented live educational programs to schools and nature groups across the US, enabling us to personally educate 24,495 children and adults. We provided images of pallid bats for an educational boardwalk sign at the Osoyoos Desert Society, provided fact checking for a children's television program with the BBC and provided video footage for the TV program "Monumental Mysteries."
